ORDINANCE 179

AN ORDINANCE AMENDING SECTION 14 (FEES) OF ORDINANCE NO. 114 OF THE VILLAGE OF LOCH ARBOUR, ENTITLED "AN ORDINANCE GOVERNING, REGULATING AND FIXING LICENSE FEES OF BUSUNESS, TRADES AND OCCUPATIONS IN THE VILLAGE OF LOCH ARBOUR, IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY, AND PRESCRIBING PENALTIES FOR THE VIOLATION THEREFOR, AND REPEALING ORDINANCES NOS. 9, 14 AND 75 OF SAID VILLAGE."

BE IT ORDAINED, by the Board of Trustees of the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, as follows:

Section A. Section 14 (Fees) of Ordinance No. 114 entitled "An Ordinance Governing, Regulating and Fixing License Fees of Businesses, Trades and Occupations in the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, and Prescribing penalties for the Violation Therefore, and Repealing Ordinance Nos. 9, 14 and 75 of said Village", is hereby amended to read as follows:
