OLD BUSINESS

A. Ordinance 2017-426 – The Deputy Mayor read the Ordinance by Title and advised of its publication in summary in *The Coaster* on March 16, 2017.

ORDINANCE NO. 2017-426
AN ORDINANCE TO EXCEED THE CALENDAR YEAR 2017
MUNICIPAL BUDGET APPROPRIATION LIMITS AND
TO ESTABLISH A CAP BANK
(N.J.S.A. 40A:4-45.14)

BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour as follows:

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1, et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Board of Commissioners of the Village of Loch Arbour in the County of Monmouth finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous

year's final appropriations, in the interest of promoting the health, safety and welfare of its citizens; and.

WHEREAS, the Board of Commissioners hereby determines that a 3% increase in the budget for the said year, amounting to \$23,481.21 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Board of Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Village of Loch Arbour shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3%, amounting to \$23,481.21 and that the CY 2017 municipal budget for the Village of Loch Arbour be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED that a certified copy of this ordinance, upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

UPON MOTION of Commissioner Cheswick, seconded by Commissioner D' Angelo, carried, that the meeting be opened for comments on the said Ordinance only.

There being no public comments, and UPON MOTION of Commissioner Cheswick, seconded by Commissioner D' Angelo, carried, that the public hearing be closed.

UPON MOTION of Commissioner D' Angelo, seconded by Commissioner Cheswick, carried, that said Ordinance 2017-426 be and the same is hereby adopted on final reading, directing the Clerk to post and publish as required by law.

- A. Tax Issue/Special School Election Commissioner Cheswick stated the Election held on April 4, 2017 results were as follows: 93 yes 4 no, in favor of the Village School Age Children attend the WLB and Shore Regional School Districts.
- B. Special School Election, April 4, 2017: The public question was approved by a vote of 93 to 4; the required Certification has been submitted to the County Clerk and the Secretary of State.
- C. Update of Improvements to Euclid Avenue, Phase II and Phase III. Dan Mason reported the project is actively in process. The project should be completed on or before April 30, 2017.
- D. Local Government Ethics Law Financial Disclosure Law All local government officials are required to complete and file the Financial Disclosure Form with the Municipal Clerk annually on or before April 30th of each ear. The state is requiring all forms be electronically filed. A password and the website was sent to each official, so the form can be completed online and transmitted to the State.
- E. Easter Egg Hunt/Breakfast with the Easter Bunny Saturday, April 8, 2017 with the residents of the Borough of Allenhurst and Borough of Interlaken. Pancake Breakfast with the Easter Bunny at the Allenhurst Firehouse from 9:00 am 11:00 am. Immediately following there will be an Easter Egg Hund at the Allenhurst Park, Main Street.
- F. Clean Ocean Action Spring Beach Sweeps scheduled for Saturday, April 22, 2017, 9:00 am 12:30 pm. Participants are urged to wear hats, boots, sunscreen and bring gloves.

Marlaina Loushine, Euclid Avenue, asked about how the board members were chosen. Dan Mason stated Mayor Fernicola recommended the Board Members to the County Executive Superintendent of Schools, but the County Executive Superintendent of Schools will appoint the new Board Members. In November, 2017 all Board Members terms will expire and all interested parties will run for a seat on the School Board.
