**C. Resolution 2017-65:** UPON MOTION of Commissioner Cheswick, seconded by Mayor Fernicola, carried that the following Resolution be adopted:

WHEREAS, the Mandatory Source Separation and Recycling Act, P.L. 1967, c. 102, established a recycling fund from which tonnage grant may be made to municipalities in order to encourage local source separation and recycling programs; and,

WHEREAS, it is the intent and spirit of the Mandatory Source Separation and Recycling Act to use the tonnage grants to develop new municipal recycling programs and to continue and to expand existing programs; and,

WHEREAS, the New Jersey Department of Environmental Protection has promulgated recycling regulations to implement the Mandatory Source Separation and Recycling Act; and,

WHEREAS, the recycling regulations impose on municipalities certain requirements as a condition for applying for tonnage grants, including but not limited to, making and keeping accurate, verifiable records of materials collected and claimed by the municipality; and,

WHEREAS, a resolution authorizing this municipality to apply for such tonnage grants will memorialize the commitment of this municipality to recycling and to indicate the assent of the Board of Commissioners to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and,

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Loch Arbour that the Village of Loch Arbour hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection.

BE IT FURTHER RESOLVED that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund used solely for the purposes of recycling.

- Execution of the required Indemnification and Hold Harmless Agreement to be submitted to the Village Clerk on or before August 20, 2017, executed by the appropriate Troop officials;
- All participants to leave the beach and The removal of all debris and other trash not later than 8:00 AM on Sunday morning so as to avoid conflict with the daily operations of the Village Beach Staff;
- 3. Open fire not to exceed 3' x 3' to be monitored by adult chaperones at all times.

WHEREAS, C.72, P.L.1994, requires that the Tax Collector file an Affidavit of Tax Bill Mailing that certifies the date by which all original bills were mailed and the date by which payments will be received without interest; and,

WHEREAS, final tax bills for the Village of Loch Arbour were mailed later than the date required by statute due to delays by the State and County in certifying the tax rate and the Tax Collector has extended the due date for payments for the third quarter 2017 to August 28, 2017 (not less than 25 days from the date of mailing) without any additional grace period.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Loch Arbour that they hereby memorialize the action of the Tax Collector in setting the new due date for third quarter 2017 payments to be received without interest.
