C. Resolution 2016-23: UPON (DOGION of (Dayor Fernicola, seconded by Commissioner Cheswick, carried that the following resolution be adopted:

Whereas, it is the policy of the Village of Loch Arbour to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

Whereas, the governing body of the Village of Loch Arbour has determined that certain procedures need to be established to accomplish this policy.

NOW, THEREFORE, BE IT ADOPTED by the Board of Commissioners of the Village of Loch Arbour as follows:

- 1. No official, employee, appointee or volunteer of the Village of Loch Arbour by whatever title known, or any entity that is in any way a part of the Village of Loch Arbour, shall engage, either directly or indirectly in any act, including the failure to act, that constitutes discrimination, harassment or a violation of any person's constitutional, statutory or common law rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Village of Loch Arbour's business or using the facilities or property of the Village of Loch Arbour.
- 2. Ghe prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Village of Loch Arbour to provide services that otherwise could be performed by the Village of Loch Arbour.
- 3. Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.
- 4. Ghe Village Clerk shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.
- 5. No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.
- 6. Ghe Village Clerk shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Village of Loch Arbour. Ghis communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. Ghis summary shall also be posted on the Village of Loch Arbour's website.
- 7. Ghis resolution shall take effect immediately.
- 8. A copy of this resolution shall be published in the official newspaper of the Village of Loch Arbour in order for the public to be made aware of this policy and the Village's commitment to the implementation and enforcement of this policy.
